## Dog Training Agreement

This agreement (hereinafter referred to as Agreement) is made and entered into in Thomson, McDuffie County, Georgia, on the \_\_\_\_\_ day of \_\_\_\_\_ 20 \_\_\_\_\_, by and between **Quality K9 Concepts LLC**, 1339 Union Church Rd, Thomson, Georgia 30824 (hereinafter referred to as Trainer) and

(hereinafter referred to as Owner).

Now therefore, in consideration of the mutual promises herein set forth, the receipt and sufficiency of which is hereby acknowledged, Trainer and Owner agree as follows, to-wit:

1. Owner agrees, acknowledges, and represents that he/she/it is the lawful owner of the canine to be trained under the terms of this Agreement and that the subject canine (hereinafter referred to as Dog) is further described as follows:

2. Trainer and Owner agree and understand that the Trainer offers four (4) tiers of training services which consists of specific goals and levels for training:

**TIER ONE: PUPPY TRAINING.**

**TIER TWO: BASIC OBEDIENCE TRAINING.**

**TIER THREE: ADVANCED OBEDIENCE TRAINING.**

**TIER FOUR BEHAVIOR MODIFICATION OR SPECIALTY TRAINING.**

The appropriate Tier of training as well as the corresponding fee for said training (as agreed upon between Owner and Trainer) is attached hereto and made a part hereof as Schedule 1.

3. All training fees shall be paid in advance and are non-refundable. In the event that the Tier of training agreed to between Owner and Trainer cannot be completed in accordance with Schedule 1 due to unforeseen, intervening causes not within the parties' control, Trainer may elect to extend pro-rata credit for the uncompleted training to Owner. In such an event, Trainer may provide the uncompleted portion of training at a later time to Owner's Dog or to another canine belonging to Owner.

4. Trainer shall use all of its professional abilities and expend all reasonable efforts to assure that the Dog is trained in compliance with the Tier of training attached hereto as Schedule 1. Notwithstanding the foregoing, Owner expressly understands and agrees that the effectiveness of any completed Tier of training

depends largely upon the Dog, Owner, and the environment in which the Dog is placed. Factors that are beyond Trainers control, also include but are not limited to:

a) future health of the Dog; b) regular and routine training reinforcement activities which the Owner **must** perform with the Dog; c) the relationship of mutual respect and trust that must be maintained between the Dog and Owner; and d) maintenance of a healthy and safe home and environment for the Dog. For these reasons, Owner and Trainer understand and agree that Trainer does not and cannot warrant or guarantee that the Dog will always respond to commands given by Owner.

5. Owner agrees to indemnify, defend, and hold Trainer absolutely harmless from and against any demand, claim, action, cause of action, liability, loss from personal damage, loss from property damage, or loss from wrongful death and/or any other form of loss, injury or damage whatsoever, relating to, imposed on, or incurred by Owner or by any other third party by reason of any behavior or conduct by the Dog both during and after any Tier of training provided by Trainer.

6. Owner and Trainer understand and agree that this Agreement and the Schedule 1 attached hereto, contains the entire understanding by and between the Owner and Trainer and no other representations, inducements, promises or agreements, oral or otherwise, between the parties not embodied herein, shall be of any force or effect.

7. Owner and Trainer understand and agree that this Agreement shall be interpreted, construed and in all respects governed by the laws of the State of Georgia and that sole venue and jurisdiction over any litigation arising hereunder shall be in Columbia County, Georgia.
